Hazards from the substance or mixture

: Highly flammable liquid and vapor. Fire will produce dense black smoke. Exposure to decomposition products may cause a health hazard. The vapor/gas is heavier than air and will spread along the ground. Vapors may accumulate in low or confined areas or travel a considerable distance to a source of ignition and flash back. Runoff to sewer may create fire or explosion hazard.
